The Floene Ethics and Conduct Committee is an internal and independent structure, reporting to the Fiscal Council, responsible for monitoring the implementation of the Code of Ethics and Conduct, as well as clarifying doubts regarding its application. It is also responsible for receiving and addressing information transmitted under the *ComunicaÉtica* - Irregularities Communication - regarding alleged irregularities or violations of the norms of the Code of Ethics and Conduct or internal regulations and rules related to accounting, internal accounting controls, auditing, and combating corruption, banking and financial crime. Adolfo Mesquita Nunes was born on November 29, 1977. He is a non-executive member of the Board of Directors of Galp since April 12, 2019. Additionally, he has been the Lead Independent Director of the Galp Board of Directors since May 3, 2023.

He is a partner at Gama Glória Sociedade de Advogados. He is a Guest Assistant Professor at Nova SBE and an arbitrator in Public Law at CAAD - Center for Administrative Arbitration.

Previously, he served in the XIX and XX Governments as Secretary of State for Tourism, from February 2013 to November 2015, and was also a member of the Portuguese Parliament from June 2011 to February 2013.

He began his career as a trainee lawyer in September 2000 at the law firm Morais Leitão, Galvão Teles, Soares da Silva e Associados. From April 2005 to June 2011, he worked as a senior associate lawyer at Morais Leitão, Galvão Teles, Soares da Silva e Associados. From June 2002 to August 2003, he served as an advisor to the City Councilor of Lisbon, Pedro Feist.
