Who is responsible for processing my personal data: Within the scope of this data processing activity and for the purposes of the General Data Protection Regulation (GDPR), there is joint controllership. Therefore, the following entities are jointly responsible for processing your personal data for the purposes indicated below in this Personal Data Protection and Privacy Policy (hereinafter the “**Policy**”):

The data collected will be processed only for the purposes of organising and promoting the event “**Unlocking Biomethane: A Successful Partnership Between Farmers and Energy Players**” (hereinafter the “Event”), held jointly with the European Parliament, Floene, CAP and GD4S.

For any purposes for which you have provided consent, you may withdraw such consent freely and at any time, without any adverse consequences. However, withdrawal of consent shall not affect the lawfulness of processing carried out based on consent previously given. Should consent be withdrawn, the Data Controllers will immediately cease processing the personal data for the relevant purpose and delete it, unless there is a need to process or retain the data in order to comply with legal and/or contractual obligations or another lawful basis for processing applies. Personal data will be retained for one (1) year after collection, unless a longer period is required to comply with legal obligations (for the duration defined therein) or, in the event of administrative or judicial proceedings, up to six months following the final and unappealable court decision.

Failure to provide consent for the collection and dissemination of images and voice will not prevent you from participating in the Event.

How personal data will be processed: Personal data will be processed by the Data Controllers within the scope of the purposes described above and in accordance with each organisation’s internal rules, using appropriate technical and organisational measures to ensure the security and confidentiality of the data, in particular against unauthorised or unlawful processing and accidental loss, destruction or damage.

The processing of data under this Event will not involve automated individual decision-making. Voice and image data may, where consent is given, be used in unedited, edited or revised formats within the Data Controllers database, for informational and non-commercial purposes, including publication on the Data Controllers intranet, corporate websites, social media or press.

Recipients of personal data: Personal data may be disclosed to companies providing services to the Data Controllers (“Processors”), bound by written contract or other legally binding instrument, which may only process the data for the purposes defined therein and in accordance with the instructions of the Data Controllers. These Processors are not authorised to process the data, directly or indirectly, for any other purpose or for their own benefit or that of a third party.

Where there is a legitimate interest in intra-group data sharing, personal data may be transmitted, for internal administrative purposes, among companies within the respective corporate group of the Data Controllers.

In compliance with legal and/or contractual obligations, personal data may also be disclosed to third parties acting as independent data controllers, including judicial, administrative, supervisory or regulatory authorities, as well as entities lawfully carrying out data compilation, fraud prevention, market research or statistical analysis.

The Data Controllers may also transfer personal data outside the European Economic Area, where necessary for the performance

of a contract or compliance with a legal obligation, ensuring that such transfers comply with applicable legislation, notably Chapter V of the GDPR. This may be ensured, for example, by transferring data under an adequacy decision of the European Commission, standard contractual clauses approved by the Commission, binding corporate rules, or any other legally recognised mechanism. You may obtain further information regarding the specific entities to whom data may be disclosed by contacting the Data Controllers through the contact details indicated in this Policy under the section on the exercise of rights.

What rights do I have regarding my personal data: As a data subject, and where applicable, you may exercise the following rights (i) right of access, (ii) right to rectification, (iii) right to erasure, (iv) right to restriction of processing, (v) right to data portability, and (vi) right to object (including the right to withdraw consent). You also have the right to (i) lodge a complaint with the competent supervisory authority — in Portugal, the Comissão Nacional de Proteção de Dados (CNPd) — and (ii) seek judicial redress and/or compensation if you believe that the processing of your personal data infringes your rights or applicable data protection and privacy legislation.
